03. <u>EXTENSION OF AGREEMENT SIGNED BETWEEN CANTONMENT BOARD</u> <u>CHAKRATA AND ANAND BEHL VERMA & CO. FOR HIRING OF SERVICES OF</u> <u>CHARTERED ACCOUNTANTS FOR THE IMPLICATION OF ACCRUAL BASED</u> <u>ACCOUNTING SYSTEM IN CHAKRATA CANTONMENT BOARD.</u>

Reference GEM Contract No.GEMC-511687753987550 and application dated 01.06.2023 received from Anand Behl Verma & Co.

Office report

As per the above referred contract an agreement was signed between M/s Anand Behl Verma & Co. and Cantonment Board, Chakrata for hiring of services of Charted Accountants for the period of 24 months from 04.06.2021 to 03.06.2023.

Since the above said agreement has expired on 03.06.2023 and for hiring of new CA certain time period is required as the work carried out by the ibid firm has been satisfactory. Hence it is proposed to extend the said contract on the terms similar to the original agreement, till finalization of tendering process.

Accordingly matter is put-up before the Board for consideration.
