03. <u>EXTENSION OF AGREEMENT SIGNED BETWEEN CANTONMENT BOARD</u> <u>CHAKRATA AND ANAND BEHL VERMA & CO. FOR HIRING OF SERVICES OF</u> <u>CHARTERED ACCOUNTANTS FOR THE IMPLICATION OF ACCRUAL BASED</u> <u>ACCOUNTING SYSTEM IN CHAKRATA CANTONMENT BOARD.</u>

Reference GEM Contract No. GEMC-511687753987550 and CBR No.03 dated 13.06.2023.

Office report

As per the above referred contract an agreement was signed between M/s Anand Behl Verma & Co. and Cantonment Board, Chakrata for hiring of services of Charted Accountants for the period of 24 months from 04.06.2021 to 03.06.2023.

Since the above said agreement has already expired on 03.06.2023. Therefore the matter was put-up before the board for extension of the ibid agreement and board vide its CBR No.03 resolved that three months extension will be given on the terms similar to the original agreement. Now in the matter the tendering process is under correspondence, hence it is proposed to extend the said contract on the terms similar to the original agreement, till finalization of tendering process.

Accordingly, matter is put-up before the Board for consideration.

<u>Res.03</u> Considered the matter and Board resolve that the contract is further extend on the terms similar to the original agreement, till finalization of tendering processes or three months whichever is earlier.

105 FIXING OF MINIMUM SERVICE CHARGES FOR SERVICE CONTRACT

Reference CBR No. 6 dated 29.04.2022.

This Board approved 5% service charges for all manpower outsourcing service vide CBR No.6 dated 29.04.2022.

Technical issue found on scrutiny of one of the bid (GEM Bid No.- GEM/2023/B/3404657) on GEM that this office set 5% Minimum service charges for all service bids related to manpower outsourcing vide CBR No. 6 dated 29.04.2022. However GEM allowed the bidders quoted their rates 3.85% which is GEM Default service charges for this types of services whereas this office set/filled 5% service charges while publishing the bid online in GEM.

In this connection CBR No. dated 29.04.2022 GEM tender documents, PDDE, CC letter No. 82562/Ruling/C-493, Dated 14-03-2022 along with relevant documents are placed on the table for suitable decision in the matter.

<u>**Res.05**</u> Matter discussed in length by the board and under the reference of OM No. F.6/1/2023-PPD dated 06/01/2023 Board resolved to fix the minimum charges in procurement of Manpower Outsourcing Services @ 3.85%, as proposed by the GeM.

Reference Tender Reference No. 1010/8/MSW/Manpower/2023, Dated 29-04-2023 and GEM (Government E- Market) Bid No. (GEM/2023/B/3400952).

To consider 303 e-bid though GEM received online and opened the technical bid as per schedule mentioned in tender document for Outsourcing of Casual Labour on Contractual Basis to Cantonment Board, Chakrata for Sanitation Work tender. However, on scrutiny it is found that bid extension request send to all 303 bidders for further processing of tender but till date not all bidder accept or reject the bid extension request online on repeated contacting the bidders by this office.

Other technical issue found on similar types of bid (GeM bid No.-GEM/2023/B/3404657). on GEM that this office set 5% Minimum service charges for all service bids related to manpower outsourcing vide CBR No. 6 Dated 12-12-2021. However, GEM allowed the bidders quoted their rates 3.85% which are GEM Default service charges for these types of services whereas this office set/filled 5% service charges while publishing the bid online in GEM.

In this connection all relevant document along with newspapers cutting of tender notice are put to table for suitable decision in this regard.

Res.06 Matter discussed in length by the board and board resolved to cancel the tender No. 1010/8/MSW/Manpower/2023 dated 29/04/2023 and GEM Bid No. (GEM/2023/B/3400952). Board further resolved to float new tender with minimum Service charge @ 3.85%, as proposed by GeM. to extend equal opportunity to all the bidders and to avoid litigation.

However technical issue found on scrutiny of bid on GEM that this office set 5% Minimum service charges for all service bids related to manpower outsourcing vide CBR No. 06 dated 29.04.2022. However, GEM allowed the bidders quoted their rates 3.85% which are GEM Default service charges for these types of services whereas this office set/filled 5% service charges while publishing the bid online in GEM.

In this connection all relevant document along with newspapers cutting of tender notice are put to table for suitable decision in this regard.

<u>Res.07</u> Matter discussed in length by the board and board resolved to cancel the tender No. 6/6/Contract/2023 dated 01/05/2023 and GEM Bid No. (GEM/2023/B/3404657).
