TERMS AND CONDITIONS OF TENDER:-

- 1. The quoted rates include drivers, Fuel and other expenditure of the vehicle, MSW transportation and Cantt Board does not pay anything except quoted rates.
- 2. THIS IS THE RESPONSIBILITY OF CONTRACTOR TO PAY ALL STATUTORY TAXES TO BE PAID.
- 3. The contractor should insure that person engaged by him for above work and doesn't have any criminal record.
- **4.** If evening trip for civil area is required as per the requirement for collection of garbage, the charges will be paid per trip wise to contractor for that particular trip (amount for per trip drive by dividing the monthly quoted amount by thirty).
- 5. The vehicle should be covered during the transportation of garbage.
- 6. The vehicle should having the capacity of loud speaker so announcement.
- 7. The firm/Supplier provides mobile number of all drivers who are engage to garbage vehicle. The firm/supplier strictly follows the instructions of Board employee who is authorized by the CEO/Board.
- 8. It will be responsibility of firm/contractor for the security and all the risks covered of the employee/ staff appointed by him for the work. And it will be responsibility of the contractor in case of accident or any other accident of the vehicle.
- 9. The contract of the work will be for one year and extended for further period of 24 month on the terms & conditions are fixed by the Cantonment Board.
- **10.** Contractor has to deposit 3% of estimated cost/or rates as arrived at financial bid as Security deposit within one week of finalization of tender though e-Chhawani Portal i.e. https://echhawani.gov.in.
- 11. The security deposit will be refunded after the successful completion of work/expired the term.
- 12. The Board has the right to terminate/ cancel the contract in case of work not executed properly due to negligence to the concerned firm/contractor and the same will be compensated from the security deposit by him.
- 13. The Board will not be responsible for any dispute between the firm/contractor and the staff appointed by him regarding salary and service condition.

- **16.** If any damage is cause to the Govt. Property by the firm/contractor by mistakes/lapse, the same will be compensated by bill/ security deposits of the concerned firm/contractor.
- 17. In case the firm /contractor quit the work before schedule time, the Board has the right to forfeit the security deposits of the contractor/ firm.
- **18.** The firm/contactor will provide stamped paper and necessary documents for the execution of contract.
- 19. The Board will not pay any interest in case of late payment of bill or on the security deposits.

- 20. The firm /Contractor/Company should visit the site/area before filling in and submitting the tender to get fully acquainted with the scope of work as no claim whatsoever will be entertained for any alleged ignorance thereof.
- 21. The CEO/Board reserves the rights to cancel any of all tenders without any reason and increases or decreases the time of work.
- 22. Incomplete/cutting tender form will be rejected. Conditional tender not accepted.
- 23. The contractor shall be responsible for fulfilling all his obligations towards Government, Local Body, other organization, all expenditure like Fuel and the person deployed(Driver) by him.
- 24. That in the event of any loss occasioned to Cantonment Board, Chakrata, as a result of any lapse on the part of the contractor which will be established after an enquiry conducted by the Cantonment board, Chakrata said loss can be claimed from the contractor up to the value of the loss. The decision of CEO of the Cantonment Board, Chakrata will be final and binding of the agency.
- 25. The personal engaged have to be extremely courteous with very pleasant mannerism in dealing with the staff/public/visitors and should project an image of utmost discipline. Cantonment Board, Chakrata shall have right to have any person removed in case of staff complaints or as decided by the Officer-incharge /HOD of the Cantt Board Chakrata if the person is not performing the job satisfactory or otherwise. The contractor shall have to arrange in suitable replacement in all such cases.
- 26. In case any public complaint is receive to Misbehaviour/of contractor personals, and it is found true after inquiry by CEO a penalty of Rs. 1000/- for each such incident shall be imposed and same shall be deducted from, the contractor's bill.
- 27. Any damages or loss caused by the contractor's persons to Cantt Board Chakrata in whatever from the cost of the thing to be damaged and addition of Rs. 1000/penalty will be imposed and deducted from the bill of contractor.
- 28. The contractor shall not engage any sub-contractor or transfer the contract to any other person in any manner.
- 29. If a result of post payment audit any overpayment is detected in respect of any work done by the agency of alleged to have done by the agency under the tender, it shall be recovered by the Cantt Board Chakrata from the agency.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Purchase Preference (Centre)

Bid reserved for Make In India products: Procurement under this bid is reserved for purchase from Class 1 local suppliers as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document 50%. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

3. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

4. Purchase Preference (Centre)

Preference to Make In India products (For bids less than 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended

from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document 50%. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar/URC for that product/service category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid.
