## 04. NOTING OF GAZETTE NOTIFICATION REGARDING PROVIDING INCENTIVES/REBATE TO THE AVAILING E-CHHAWANI SERVICE ONLINE FOR PAYMENT OF TAXES BY SELF SERVICES MODES.

**Office report:-**

The Sub Labour Commissioner Dehradun vide its order dated 27/03/2023 directed that Cantonment Board Chakrata is a central autonomous body hence the rules of the Central government are applicable for hiring of outsource staff.

The order was put-up before the Board and Board vide its CBR No. 05 dated 29/03/2023 considered the matter and resolved that for future engagement of contractual employees minimum wages should be paid as per narrick rates approved time to time by the Central govt.

In this regard Ministry of Labour and Employment vide letter No. 1/7(1)/2024-LS-II dated 01/04/2024 has issued the revised rates of Variable Dearness Allowance, same are put-up before the Board for noting please.

## 07. <u>CANCELLATION OF TENDER FOR "SUPPLY OF MTS AND OTHER</u> <u>MISCELLANEOUS STAFF ON OUTSOURCE BASIS TO CANTONMENT BOARD</u> <u>CHAKRATA".</u>

Reference Tender NIT No. 6/6/Contract/Misc. Staff/2024 dated 01/01/2024, GEM bid No. GEM/2024/B/4420686 dated 01/01/2024 read with Cantonment Board Chakrata letter No. 6/6/Contract/Misc. Staff/2024/70, letter No. 6/6/Contract/Misc. Staff/2024/71 dated 15.03.2024 and complaint letter dated 27/03/2024 from all the outsourced employees.

### Office Report

Cantonment Board Chakrata Published tender NIT No. 6/6/Contract/Misc. staff/2024 dated 01.01.2024 on GEM portal. After receiving total No. of 318 Bids Cantonment Board Chakrata Finalized 251 qualified in Technical evaluation and after Technical Bid evaluation the Bid of the M/S Ramu Housekeeping Contractors was auto selected (system selected) by the GEM portal in financial Evaluation.

In accordance with the policy of the Tender and GEM portal, Cantonment Board Chakrata issued Supply order to the Contractor with letters under reference i.e. letter No. 6/6/Contract/Misc. Staff/2024/70 and letter No. 6/6/Contract/Misc. Staff/2024/71 dated 15 march 2024 and directed for commencement of contract from 01.04.2024.

Subsequently, in order to ensure smooth working of the Office, the CEO, Chakrata Cantt. suggested the contractor to continue with the existing contractual employees working at the Cantonment Board Chakrata as the employees are performing their duties with utmost satisfaction of the superiors and are familiar with work culture at Cantt Board Chakrata.

Acting upon which, correspondence was carried out between the contractor and the employees. Thereafter all the outsourced employees submitted a written complain pertaining to the issue that contractor is demanding an exorbitant sum of Rs. 20,000 from unskilled employees, Rs. 25,000 from semi-skilled employees and Rs. 30,000 from skilled employees, in the name of facilitation charges. The amount which is being demanded is almost worth two-month salary of

the employees. Moreover, when the contractor was questioned on whether demanding of such exorbitant amount is in accordance with the rules and if the receipts will be provided to the employees after submission of the money, the contractor vigorously threatened the employees to either submit the money as asked or to leave their services from 01/04/2024. Considering upon the fact where the employees had to pay two-month worth of salary for a 12-months working contract is pitiful and cruel situation for any labour and is a clear exploitation of the hard-earned money, thus the employees unanimously neglected the demands of the contractor.

In continuation to the above, the Contractor established a telephonic communication with this Office for conducting an interview on 28.03.2024. The interview was held on 28.03.2024 under the association of competent personnel from Cantonment Board Chakrata and M/s Ramu Housekeeping Contractors and it was found that none of the candidates recommended by the firm are suitable and were highly unprofessional.

As it is not viable to tolerate such an inhumane situation wherein clear molestation of the labour is being carried out by the contractor in front of the Board, thus Cantonment Board Chakrata vide letter No. 6/6/Contract/Misc. Staff/2024/73 dated 28/03/2024 referred the matter to the Dy. Chief Labour Commissioner (Central) for seeking suitable action in the matter, resultant to which the Dy. Chief Labour Commissioner vide their office letter No. 95(Misc)/2024-ALC dated 03/04/2024 intimated the department of Ministry of Labour & Employment has taken a very serious view in the ibid matter and advised that being Principal Employer the Board shall take strictest possible action as per law against the contractor.

In this connection, all relevant documents are put-up before the Board for take necessary action in the matter.

**Res.07** The Board discussed the matter at length and resolved to initiate proceeding to blacklist the firm. Further, the Board resolved to initiate action against the firm and to initiate remedial action to prevent such incident in the future.

# 08. <u>SANCTION FOR GRANT OF DEARNESS RELIEF TO PENSIONERS/FAMILY</u> PENSIONERS, OF CANTT BOARD EMPLOYEES IN UTTARAKHAND.

Reference PDDE CC Lucknow letter No. 9334/DR/Uttarakhand/LCP dated 26/04/2024 read with Uttarakhand GO No. 199032/XXVII(7)/E-22807/2022 dated 14/03/2024.

#### Office Note:-

The PDDE CC Lucknow vide the letter referred above issued approval for grant of Dearness Relief @ 50% of their basic pension w.e.f 01/01/2024 to the pensioners of Cantonment Board Chakrata as per terms and conditions contained in Uttarakhand GO No. 199032/XXVII(7)/E-22807/2022 dated 14/03/2024.

Accordingly, matter is put-up before the Board for approval of the same.

# 09. <u>INVESTMENT OF CANTT FUND MONEY FOR SALARY, PENSION AND</u> <u>TERMINAL BENEFITS RELATED LIABILITIES.</u>

To consider the matter investment of Cantt Fund Money as fixed deposit for its gainful utilization and better financial management.

A grant of Rs. 5 crore was credited into the account of Cantonment Board Chakrata on 29/03/2024, subsequent to which the closing account of Cantonment Board Chakrata for the FY-2023-24 comes upto Rs. 4,99,74,038.38. Accordingly, it is proposed that a sum of Rs. 2,00,00,000/- into four segments of Rs.50,00,000/- each to be invested in a Nationalized/Govt. Bank for gainful utilization and better financial management.

In this regard the interest rates of two Nationalized/Govt. banks i.e. PNB and SBI have been obtained and it is observed that for general term deposits less than 2 crore for a period of 180 days to 270 days, the interest rate of PNB if 6.00% whereas the interest rate of SBI is 5.75% for similar time period. In this regard all relevant documents are put-up before the Board for taking suitable decision in the matter.
