04. <u>BUDGET ESTIMATES FOR THE YEAR 2025-26(REVISED) AND 2026-</u> 27(ORIGINAL).

To consider and approve the Budget Estimates of the Board for the year 2025-26 (Revised) and 2026-27 (Original) as required under Rule 21, 22, 24, 25 & 26 of Cantonment Act Rule 2020.

In this connection the draft budget estimates drawn up in Form No. 1S(1B) is placed on the table.

05. <u>PROPOSAL FOR RECLASSIFICATION OF B-4 LAND ALONGSIDE NH 707A AT</u> <u>GATE NO. 1 INTO CLASS C LAND OUT OF GLR SURVEY NO. 272, B-4 LAND UNDER</u> <u>THE MANAGEMENT OF DEO DEHRADUN.</u>

As land bearing Survey No. 272, classified as B-4 land, falls under the management of the Defence Estates Officer (DEO), Dehradun Circle. The said land is strategically located at the very first entrance point to the markets of the Chakrata Cantonment Board area, making it highly significant from both economic and developmental perspectives. A visually appealing and well-developed entrance is particularly crucial for a hill station like Chakrata, as it leaves a lasting first impression and enhances the overall charm of the destination.

Given the geographical limitations of hilly regions, there is very limited usable land available for the development of civic amenities and the creation of employment opportunities for the local population. In view of this, it is proposed land alongside NH 707A at Gate No. 1 out of Sy. No. 272 be reclassified from B-4 land to Class C land for municipal purpose.

The proposed reclassification aims to shift the land use from 'Forest' to 'Municipal' purpose. This will allow the Cantonment Board Chakrata to utilize the land for vital community development projects such as the construction of a shopping complex, public utility infrastructure, and other essential civic amenities. These initiatives are expected to significantly enhance the urban landscape, improve public services, and increase tourist inflow, thereby contributing to the overall socioeconomic development of the region.

In light of the above, it is proposed that a formal request for reclassification of the aforementioned land be submitted to the DEO, Dehradun. All relevant documents in this regard are hereby placed before the Board for its kind consideration and necessary approval.

Res.05 The board approved the reclassification of proposed 'B-4' land into Class 'C' land. The board further resolved to take up the matter to the Station Headquarter for obtaining of NOC since the subjected land is adjacent to defence A-1 land.

06. <u>CHANGE OF PURPOSE OF SY. NO. 246/145 'CLASS C' LAND UNDER THE</u> <u>MANAGEMENT OF CANTONMENT BOARD DESCRIPTED AS 'GIRLS PRIMARY</u> <u>SCHOOL, PUBLIC READING ROOM AND DISPENSARY'</u>

As per records, Sy. No. 246/145 is classified as Class C land under the management of the Cantonment Board Chakrata. The land is described as being used for a Girls Primary School, Public Reading Room, and Dispensary, with a total area of 2,949.00 sq. ft.

Due to a decline in the number of girl students, the premises were being utilized as a Cantonment Primary School, Kailana. However, the building has significantly deteriorated and has exceeded its intended lifespan, posing a safety hazard. To prevent any potential accidents and ensure the safety of students and staff, the school has been permanently to Cantt inter college for maintaining functionality, for proper utilization of space at CIC and for better guidance under one principal.

At present, there is no functioning dispensary or public reading room on the said land. Furthermore, due to low student strength, most of the rooms in the building remain underutilized.

In view of the above, it is proposed that the property be redeveloped for discharge of municipal purpose Accordingly, it is proposed to change the existing purpose of Sy. No. 246/145 from "Girls Primary School, Public Reading Room and Dispensary" to "Municipal Purpose".

All relevant documents in this regard are placed before the Board for kind consideration and approval.

Res.06 The board considered and approved to submit requisite proposal to the competent authority for changing the existing purpose of Sy. No. 246/145 from "Girls Primary School, Public Reading Room and Dispensary" to "Municipal Purpose".

07. GRANT OF ENHANCED DA TO CANTT. FUND EMPLOYEES @55%.

To consider and approve grant of enhanced D.A. to the employees of Cantt. Board Chakrata from existing 53% to 55% w.e.f. 01.01.2025, as granted by the Govt. of Uttarakhand GO No. 295029/xxvii-10/2025-\$-200807/2022, dated 06.05.2025 to their employees. The Cantonment Board employees are also eligible to get the said enhanced DA on the same term & condition as per clause 14(1) of memorandum of settlement arrived at between Cantonment Board Chakrata and their workman.

The financial implication for payment of above DA would be 25,538.00 per month budget provision exists.

The necessary proposal for revision of Dearness Allowance from 53% to 55% w.e.f. 01.01.2025, as granted by Uttarakhand Govt. be submitted to the PDDE, Central Command for approval.

08 SALARY INCREMENT DUE TO FINANCIAL CHALLENGES.

Reference to the Representations Submitted by Outsourced Employees of Cantonment Board Chakrata Regarding Salary Increment.

Office Report

To consider the matter regarding the increment in the salary of Outsourced Employees.

Cantonment Board Chakrata is a hilly cantonment where, due to limited infrastructure and higher expenditure on basic necessities, recruiting and retaining skilled employees remains a significant challenge.

Currently, the Outsourced Employees have become well-acquainted with the departmental procedures and are contributing effectively to the daily operations of the Board. Their performance has been commendable and consistent with the expectations of their respective roles.

Representations have been received from these Outsourced Employees indicating that their present salary is not proportionate to the nature and volume of work they are undertaking, and is insufficient to meet their daily living expenses.

In light of the above and after due review, it is proposed to revise and fix the salary of Outsourced Employees as per the structure given below:

11. DECLARATION OF CHOWK BAZAR, CHAKRATA AS A NO PARKING ZONE.

Office report:-

The area adjoining Chowk Bazar, Chakrata is an important point for promoting of tourism Chakrata, in this connection the Board has also made various efforts in order to revive the markets of Chowk Bazar. The Chowk Bazar area is the top most point the Sadar Bazar Market and is connected via an uphill narrow road.

The public road is Class C land inside civil area under the management of Cantonment Board Chakrata. However the same is being occupied by the parked vehicles of some local residents resulting in inconvenience for a majority of public. Moreover this exploitation of public road often leads to congestion, obstruction of traffic flow, and a decline in the visual appeal of the locality. These problems not only affects smooth pedestrian movement but also detract from the area's natural charm and attractiveness. As a result most of the tourists avoid visiting Chowk bazar and its adjoining market.

Therefore in order to revive the economy of markets & preserve the aesthetic beauty of the region, it is proposed that the area of Chowk Bazar be declared as a 'NO PARKING ZONE'. It is also proposed that a provision for a penalty of Rs. 100/day against the violator's in order to maintain order in the area.

Accordingly, the matter is placed before the Board for kind consideration and approval.

Res.10 The Board discussed the matter in length and resolved to declare the area of Chowk bazar area as a 'No Parking Zone' from 1100 hrs to 2100hrs. The Board further resolved to allot destined parking spaces for emergency vehicles/loading-unloading during the Non-Parking hrs. The board also approved the provision for a penalty of Rs. 100/day against the violator's.

Further the Audit authorities vide MFAI bearing No. Item No. 04 of QE 09/2024 have advised that, as the payment of ₹1,77,41,500, approved vide CBR No. 02 dated 14/06/2017,

was made without obtaining prior approval from the appropriate Competent Authority. Hence, the Board shall obtain *ex-post facto* sanction from the appropriate authority, i.e., Principal Director, Directorate of Defence Estates, Central Command, Lucknow, for regularizing the payment.

Accordingly the matter is placed before the board for obtaining approval of the board for submission of the requisite proposal as advised by the Audit authorities to the competent authority for regularizing the amount and to settle the MFAI.

MERGER OF DILAPIDATED CANTT FUND PROPERTIES/SHOPS WITH 20. ADJOINING SHOPS.

Office Note:-

The Board vide its CBR No. 09 dated 24/02/2022 considered the matter regarding merger of dilapidated Cantt Fund Properties/shops with adjoining shops in order to prevent further dilapidation of properties and to enhance revenue of the Board and resolved to reexamine the matter in accordance with prevailing rules and after detailed examination of all cases where merger is possible with adjoining shop be put-up before the full board for consideration.

As the Board is still varied and there is uncertainty in respect of the time which may elapse before a full board and since the property is becoming dilapidated with each passing day alongwith loss of revenue for the Board.

Therefore the matter is placed before the Board for reconsideration for merger of all similar properties which are getting dilapidated and causing loss of revenue for the Board into adjoining properties. Thereafter all property can be put into auction for fresh allotment as per rule 267 of Cantt Act 2006.

The Board discussed the matter in length and directed the CEO to constitute a committee and to carry out a survey of all the properties feasible for merger and to submit the report before the Board for further consideration.

SOLID WASTE **OUTSOURCING** FOR **JUSTIFICATION** NOTE CHAKRATA PARK, SANITATION 21. SERVICES IN MANAGEMENT CANTONMENT BOARD.

Background

The Chakrata Cantonment Board currently manages solid waste through a three-year contract with the NGO Feedback Foundation Charitable Trust (FFCT), which operates the sanitation park. This contract will expire on 01.11.2025. In anticipation, the Board has made a financial provision in the FY 2025–26 budget for continued SWM operations.

Justification for Outsourcing

Due to limited manpower, equipment, and logistical resources and lack of technical expertise the Board is not in a position to operate the sanitation park independently without incurring significant administrative and financial burdens. FFCT has demonstrated satisfactory performance over the past three years and possesses local familiarity and operational efficiency. Outsourcing to experienced NGOs also brings technical expertise, community engagement, and alignment with environmental best practices. Continuation through outsourcing will ensure service continuity and maintain quality, avoiding disruptions that may result from transitioning operations in-house.

Scope of Work

The outsourced agency will be responsible for:

- Collection, segregation, transportation, and scientific disposal of solid waste
- Maintenance of sanitation park infrastructure and equipment
- Community awareness and outreach for waste reduction
- Compliance reporting as per environmental regulations

Proposed Way Forward

- Issue an Expression of Interest (EOI) or Request for Proposal (RFP) to qualified NGOs/agencies
- Assess the feasibility of extending FFCT's engagement based on performance
- Finalize selection through a transparent and competitive process

Conclusion

Considering operational constraints and the need for uninterrupted, efficient, and sustainable solid waste management, outsourcing remains the most practical approach. Approval is requested to initiate the process for engaging an experienced NGO or competent agency for this purpose.

Res.21 The Board considered and discussed the matter in length and resolved to outsource the entire services of Solid Waste Management at Chakrata Cantt by inviting an (EOI) Expression of Interest. The board further resolved that preference would be given to existing NGO as it had been involved in the installation of sanitation park where the entire solid waste of Chakrata Cant has been effectively managed by the NGO since last three year, moreover the NGO also possess extensive expertise in addressing the challenges specific to this terrain.
