1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Purchase Preference (Centre)

TERMS & CONDITIONS

SUPPLY OF SANITATION ITEMS TO CANTONMENT BOARD CHAKRATA

1. Quantity Variation

The Purchaser reserves the right to increase or decrease the quantity of sanitation items as enclosed in Annexure-A at the time of placement of the contract/order.

2. Scope of Supply

- Supply of Sanitation Items as per specifications.
- Packing, Forwarding & Transportation.
- Loading/Unloading at consignee location.
- Delivery of items in good condition.
- Obtaining statutory clearances, if required.

The quoted price shall be inclusive of all cost components.

3. Quality Assurance

The bidder shall ensure that all sanitation items supplied are new, of standard quality, and conform to the specifications prescribed in the bid document. Any defective or sub-standard material supplied shall be replaced by the bidder at no additional cost within the stipulated period.

4. Turnover Criteria

The minimum average annual financial turnover of the bidder during the last three financial years (ending 31st March of the previous financial year) should be as specified in Point No. 10 below.

Documentary Evidence Required:

- Certified Audited Balance Sheets; or
- Certificate from Chartered Accountant/Cost Accountant.

In case the bidder is newly incorporated, turnover from the date of incorporation shall be considered.

5. Earnest Money Deposit (EMD)

Bidders shall submit EMD amounting to 2% of the estimated bid value through the GeM Portal or as permitted through the e-Chhawani Portal. (Exemption shall be allowed as per Government of India guidelines/orders.)

12. ISO Certification

The bidder or manufacturer/OEM shall possess a valid ISO 9001 Certificate or equivalent Quality Management System Certification.

13. Delivery Schedule

The successful bidder shall supply the sanitation items within the delivery period specified in the Purchase Order. Delayed supply may attract penalties as per the bid conditions.

14. Replacement of Defective Items

Any item found damaged, defective, expired, or not conforming to the prescribed specifications at the time of inspection or delivery shall be replaced by the bidder at no additional cost within the stipulated time.


